**c. Annual Open Space Evaluation.**

EAC make a motion to see a cost cutting measure starting in 2011, half of the properties for annual evaluation to every other year basis, then every two years and may be extending that to properties consistently in compliance to every five years.

**d. Traditions Infiltration Basins.**

Planning & Zoning will research how the basins are being maintained by the landscaping contractors and report findings back to the EAC at the next meeting.
