## **Upper Makefield Historical Advisory Commission (HAC) Meeting Minutes – August 20, 2012**

Present: Cynthia Maxel, Maureen Ferrazzi, Peter Crawford, Virginia Cleary and the Supervisor's Representative Larry Breeden and Historic Conservancy Jeff Marshall

- 1. <u>Minutes</u> The Minutes from the HAC meeting were approved via email and forwarded to the Board of Supervisors.
- 2. The Agenda items: The HAC welcomed our new appointee Virginia Cleary.
- 3. Agenda items: The Committee perused a letter from the Bucks County Register of Wills and Orphans' Court and the Meeting Notes from the 5/16/12 meeting Notes on the topic of Historic and Genealogical Advisory Panel. These letters have been submitted with these minutes.
- 4. Agenda item: Jeff perused a copy of the draft Preservation Ordinance for information about the categories regarding Upper Makefield Twp. Homes and historic structures. The Committee began the process of regarding the historic properties in the Township. Jeff presented an evaluation and a recommendation for each property listed based on the four categories of property significance and the Committee then evaluated his findings. The 4 Classes of resources include: Class 1: buildings, sites, districts on the National Register of Historic Sites and Building, sites, Districts eligible for the Register. Class 2: Buildings, sites, structures determined to be of high historical or architectural value to the Newtown Area Joint Municipal Zoning Map Area. Class 3: Buildings, sites, structures, and objects listed on the Inventory not meeting criteria for Class 1 or Class 2 but deserving of protection and preservation. Class4: Buildings, sites, structures, objects, districts that are historic due to their age, but whose current condition is too altered that preservation and protection would be futile.

The Committee discussed the evaluated properties and made an effort to understand the various Classes of eligibility and the impact on Upper Makefield Township. The responsibility of the Committee according to our mandate is to establish those properties worthy of protecting so that the Supervisors can make an intelligent evaluation when it comes to their demolition or preservation.

- 5. The Committee received from Maureen a 2 part letter from a local realtor Mart Dinneen entitled A Citizen's Guide to Protecting Historic Places by Constance E. Beaumont, a State and Local Policy Director for the National Trust for Historic Preservation. It was her hope that it would present some useful information on the topic for all members.
- 7. The Committee set the next meeting for 6:30 on September 24, 1012.

### ROW/OC HISTORIC & GENEALOGICAL ADVISORY PANEL 5/16/12

Meeting commenced at 3:00 p.m. in the Courthouse Lawyer's Lounge with Don Petrille and Sherla Bass. The following organizations were represented and welcomed by Mr. Petrille:

Don Petrille gave an overview of what our office has been accomplishing:

- 1. Currently imaging new Court cases;
- 2. Keeping original documents in acid free files;
- Writing an RFP regarding imaging and indexing all historic documents, including marriage licenses, death records and probate issues; and
- 4. Initiating remote access in the future, once scanning is complete.

It was noted by Gerry Vallette, and Sara Good confirmed, that OCR of 18<sup>th</sup> century files can be hard to read. The question is whether to have our ROW/OC staff do the job or outsource. Mr. Vallette stated that the Friends Historic Library in Swarthmore is doing OCR and also has on-line access for the public while the Mercer Museum does not. Sara Good noted that Terry McNeals, the former Director of the Mercer, had signed letters to accept the "long term loan" of records from the Register of Wills and Orphans' Court in the past. Ms. Good suggested that Mr. Petrille call Susan Harlman.

Mr. Vallette discussed educational initiatives from the Church of Latter Day Saints, which has on-line and indexed genealogy with no fee. However, they do charge for copies. The Mercer Museum, per Ms. Good, charges \$10 for admission for full access to their library and they also do workshops. Mr. Thomforde noted that the Pennsbury Manor conducts educational programs and would be happy to collaborate. He also suggested that Mr. Petrille contact their leadership.

Mr. Vallette related that the Massachusetts Genealogical Society lists every historic site in that state. He amusingly stated that if a County carnot take care of their records, the State must take the records. While this is also true in Pennsylvania, per Ms. Good, the Pennsylvania Historic and Museum. Commission has resisted this due to spacing considerations.

Oon Petrille has thought about exploring establishing a Records Center when the existing Courthouse is reconfigured. The facility would be fitted with humidity and light controls, and would house records of multiple offices. Ms. Good explained it may be more cost efficient for County offices to further partner with the Mercer/Spruance Museum.

Ms. Good noted that they are digitizing documents into TIF format, which her research indicates realistically only lasts about 15 years. Both Mr. Petrille and Ms. Good would like to see more collaboration with Register of Wills/Orphans' Court in the future. A tour was then led by Mr. Petrille with Ms. Good and Mr. Vallette. Both seemed pleasantly surprised by our set-up and accessibility.
