Upper Makefield Township Board of Supervisors September 21, 2011 Meeting Minutes

The September 21, 2011 public meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Bud Baldwin at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Chair Bud Baldwin, Vice Chair Tom Cino, Treasurer Mary Ryan, Member Dave Kulig and Member Dan Rattigan. PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE:

Mr. Baldwin led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

Mr. Baldwin announced that a Hurricane Irene Disaster Recovery Center will open at Neshaminy Mall on Sept. 22, 2011 at 1:00 p.m.

SPECIAL ITEMS:

Girl Scout Troop 2312 Recognition

Girl Scout Troop 2312 was recognized by the Board of Supervisors for their service project at Lookout Park, where they planted wildflowers along the sloped meadow area to increase the no mow zone for improved storm water management. EAC Chair and Girl Scout Parent, Cathy Magliochetti, provided a brief presentation of the project.

Upper Makefield-Newtown Soccer Club

Tim Duffy represented Upper Makefield-Newtown Soccer Club presenting a field usage and maintenance plan which proposes that the club assume field maintenance responsibilities in lieu of field use fees, and that the township provide an upgraded water supply. Discussion followed and the Board directed Ms. Teoli to meet with the soccer club to determine further the needs of the organization.

PUBLIC COMMENT:

Ellen Lane Novitz, Dunkin Drive, reported on the upcoming meeting regarding electric generation costs. She then provided comment on her disappointment with the September 14th Budget Workshop meeting.
