

ADVERTISEMENT FOR BIDS

The **Township of Upper Makefield**, offices located at **1076 Eagle Road, Newtown, PA 18940**, will receive sealed bids online until **11:00 A.M.**, prevailing time on **Tuesday, April 3, 2018** at which time and place the bids shall be publicly opened and read aloud for:

Contract 18-01007 – 2018 ROAD PAVING PROJECT

This contract involves the base repair, leveling, edge milling and paving of Thompson Mill Road (from Pineville Road to Jericho Mountain Road), Bridlewood Drive, Devon Drive, Buttonwood Drive, Chestnut Lane, Weatherfield Drive, Paul Douglas Court, Georgetown Circle, and Brownsburg Road, and only spot base repair on Woodhill Road from Eagle Road to Taylorsville Road in Upper Makefield Township. Improvements include 3' tapered edge milling, full width milling in the cul-de-sacs, base course repairs, tack coat, HMA wearing course, and joint sealant. Refer to a plan entitled "Location Map", dated 1/23/2018, as prepared by Tri-State Engineers, for specific locations of the project scope listed above.

All Bidding Documents and Solicitation details may be obtained at PennBid™ www.ebidexchange.com/pennbid. Click on the "Solicitations" then "View" tabs. All documents, specifications, and drawings can be obtained and secure bids submitted online at no cost. A nominal fee of 0.25% of the bid amount (up to \$5,000) is assessed only to bidders who are awarded contracts. For bidders who are not the winning bid; there are absolutely no fees.

Each bid shall be submitted in accordance with the Instructions to Bidders and must be accompanied by a Bid Bond or Certified Check for not less than ten percent (10%) of the Bid amount payable to the **Township of Upper Makefield** along with an Agreement of Surety certifying that the required Performance and Payment Bonds will be provided to the Bidder.

The successful Bidder shall be required to furnish proof of insurance and bonds for Performance, Payment, and Maintenance in such form as meets the approval of the **Township of Upper Makefield** and having as security thereon such Surety company or companies as are approved by the **Township of Upper Makefield**.

A pre-bid meeting will not be held for this project.

This project is subject to applicable provisions of Act 422, Pennsylvania Prevailing Wage Act as amended and the prevailing minimum wage rates issued by the Pennsylvania Department of Labor and Industry.

No Bidder may withdraw his bid within sixty (60) days after the date set for the opening of the bids.

The **Township of Upper Makefield** reserves the right to reject any and all bids for any cause whatsoever, to eliminate any item or items from the contract, and to waive any informality in the bids.

The **Township of Upper Makefield** reserves the right to increase or decrease any or all of the quantities of work or to omit any of them, as it may deem necessary and such increase or decrease of the quantities given for any of the items shall not be considered as sufficient grounds for granting an increase in the unit prices bid. The contractor will be paid at the unit prices bid for actual work performed in accordance with the terms of the contract.
