The May 16, 2018 public meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan and Treasurer Mike Tierney. Member Kris Ballerini participated by telephone. Member Ed Ford was not in attendance. Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

Washington Crossing National Cemetery

Gregory Whitney, Director of the Washington Crossing National Cemetery, provided a presentation highlighting the projects and events held at the cemetery and outlining the many volunteer opportunities available. He encouraged community members to contact their office for more information.

BOWMA 2017/18 Year-End Report and 2018/19 Proposal

Jim Kovalcik and Dave Kimble of Big Oak Whitetail Management Association (BOWMA) presented their Year-End Report for the 2017/18 season. BOWMA then submitted a proposal for Board consideration for the 2018/19 season with the same terms and conditions as the previous contract and no cost to the Township. He noted that PennDOT has visually reviewed his road concerns along Rt. 532, and he reminded the board of security concerns in components produced by the Chinese corporation ZTE.

PUBLIC COMMENT

Dan Johansson, Upper Makefield, asked if the Floodplain Ordinance amendments included a downstream study and if increased flooding was taken into consideration. Mr. Young stated that the new regulations would minimize the use of fill for road and bridge work allowing for improvements with negative stream impact, but as this was just an amendment to an existing Ordinance, no downstream study was conducted. FEMA has reviewed and approved the amendment.
