# Upper Makefield Township Board of Supervisors January 8, 2019 Special Meeting Minutes

The January 8, 2019 special meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:35 p.m. In attendance were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan, Member Kris Ballerini, Member Ed Ford and Treasurer Mike Tierney. Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

Mr. Cino made the following announcements:

#### **PUBLIC COMMENT**

Richard Decker, 36 VanSant Road, shared several concerns about the pending A-4 Riding Academy at Holly Farms. He stated that there are 25 horses on site and horse rehabilitation has begun on the property, the dumpsters are uncovered and overflowing, and run-off from one dumpster is going into the pond. Mr. Decker also observed an uncovered construction dumpster onsite causing trash to blow out, and truck traffic using his driveway as a turnaround. He stated that he feels the Board's adjudication is fair, and he expressed disappointment with the property owner's actions.

# Public Works Collective Bargaining Agreement

Mr. Nyman stated that consideration of the Public Works Collective Bargaining Agreement is continued until the next Board meeting to permit several Board members additional time for review.

### **Deputy Tax Collector**

Mr. Nyman referenced the request of Tax Collector Nick Ettorre to appoint William B. Jones as Deputy Tax Collector, which is permitted by the DCED. Following discussion, a motion was made by Ms. Nolan and seconded by Ms. Ballerini to appoint William B. Jones as Deputy Tax Collector for Upper Makefield Township subject to approval by the surety bond company. Motion carried by unanimous vote.

# **Open Space Updates**

Mr. Nyman provided an update on Township-owned open space parcels noting that staff is currently reviewing which parcels may be considered for conservation easements, per Board request.

## **Easement Monitoring**

Following discussion, a motion was made by Dr. Ford and seconded by Ms. Nolan to authorize staff to request a proposal from Heritage Conservancy to monitor existing conservation easements. Motion carried by unanimous vote.
