**TAX LEVY RESOLUTION
RESOLUTION NO. 2019-11-06-02**

A RESOLUTION OF THE Township of Upper Makefield, County of Bucks, Commonwealth of Pennsylvania. Fixing the tax rate for the year 2020.

BE IT RESOLVED AND ENACTED, and it is hereby resolved and enacted by the Board of Township Supervisors of the Township of Upper Makefield, County of Bucks, Commonwealth of Pennsylvania.

That a tax be and the same is hereby levied on all real property and Real Property within the Township subject to taxation for the fiscal year 2020 as follows:

Tax rate for general purposes, the sum of	<u>0</u>	mill
on each dollar of assessed valuation, or the sum of	<u>0.000</u>	cents
on each one hundred dollars of assessed valuation.		

For <u>Open Space Preservation</u> purposes including but not limited to, debt reduction and acquisition, the sum of	<u>6.3525</u>	mills
on each dollar of assessed valuation, or the sum of	<u>0.0063525</u>	cents
on each one hundred dollars of assessed valuation.		

For <u>Fire Protection</u> purposes, the sum of	<u>0.75</u>	mills
on each dollar of assessed valuation, or the sum of	<u>0.00075</u>	cents
on each one hundred dollars of assessed valuation.		

For <u>Building Construction and Debt Services</u> purposes, the sum of ...	<u>0.50</u>	mills
on each dollar of assessed valuation, or the sum of	<u>0.00050</u>	cents
on each one hundred dollars of assessed valuation.
