# **Upper Makefield Township Board of Supervisors December 3, 2019 Meeting Minutes**

The December 3, 2019 public meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan, Treasurer Mike Tierney, Member Kris Ballerini, and Member Ed Ford. Also in attendance were Township Manager David Nyman, Township Solicitor Mary Eberle, Esq. and Chief Mark Schmidt.

## PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE

Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

## **ANNOUNCEMENTS**

Mr. Cino made the following announcements:

- The Upper Makefield Police Department participates in the DARE program, educating 6<sup>th</sup> grade students at Sol Feinstone Elementary School about the dangers of drugs and alcohol. Recently, our DARE program received a generous donation from Upper Makefield Business Association. We would like to thank UMBA for their support of DARE and other local programs and scholarships that benefit our community.
- The annual Upper Makefield Fire Company Santa Parade and Food Drive will be held on Sunday, December 22, 2019. New this year-Santa will be making predesignated stops for Food Drive Pick Ups and pictures. The route with approximate times and the new Santa Stops will be released soon on fire company and police social media, the Township website and through homeowners associations. The Food Drive drop-off at Taylorsville Road Firehouse Station 71 will continue as in years past.

Mr. Cino then invited Sergeant Jones, Officer Crawford, Officer Russi and Officer Raza to the podium. These members of the UMT police department joined other Bucks County police departments and participated in the annual Shop with a Cop program at Target.
