School Real Estate and Occupational Assessment Tax Bills will be mailed the first week in July, 2021.

- 2% Discount Last Day to pay with the 2% discount is August 31
- Face Amount- Last day to pay Face Amount is October 31
- 10% Penalty added if paid after October 31

Installment Payment Option: Council Rock School District offers a threeinstallment option. Please see your bill for the due dates.

After December 31, liens will be filed on all unpaid real estate taxes.
