Upper Makefield Township Board of Supervisors June 1, 2021 Meeting Minutes

The June 1, 2021 public meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan, Treasurer Tim Thomas, Member Ed Ford and Member Karin Traina. Also in attendance were Township Manager David R. Nyman, Assistant Township Manager Judy Caporiccio, Township Solicitor Mary Eberle, Esq., Planning & Zoning Director Dave Kuhns and Chief Mark Schmidt.

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

ANNOUNCEMENTS

Mr. Cino made the following announcements:

- The next Bucks County Household Hazardous Waste Collection Event will be held at Central Bucks South High School on June 26 at 9 a.m./rain or shine. Registration is required. Visit BucksCounty.org/recycling for details and registration.
- Washington Crossing Historic Park is undergoing some renovations. The State Department of Conservation and Natural Resources, Historic and Museum Commission and the Department of General Services worked together to fund the \$8.7 million revitalization project which includes restoration to 17 sites and other facilities improvements to protect the cultural and historical significance of the site. The project is expected to be completed by the end of 2022.
- An executive session will be held following tonight's meeting for personnel and land acquisition matters.

SPECIAL ITEMS

Upper Makefield Police Department

Sergeant Mary Kate Huff was recognized for her recent promotion to the rank of sergeant. She joined UMTPD in 2007 and is the Department's first female sergeant.

The Police Department was congratulated for earning Accreditation from the Pennsylvania Chiefs of Police Association. Chief Schmidt provided an overview of the process, which began in 2019. He highlighted the benefits to the community, which include required training to ensure best practices in policing and a reduction in liability by limiting risk and exposure to lawsuits. Upper Makefield is one of 131 agencies in Pennsylvania to have achieved accredited status.
