Upper Makefield Township Board of Supervisors October 5, 2021 Meeting Minutes

ANNOUNCEMENTS

Mr. Cino made the following announcements:

- River Road is now open from Rt. 532 to Taylorsville Road. Many thanks to Township team and PennDOT for coordinating the repairs to open the canal bridge. The bridge near Lookout Park remains closed. We are continuing our efforts to work with PennDOT to get those repairs scheduled and re-open this section of River Road. For your safety and the safety of others, please do not remove the barricades.

Lot Line Change, 945 Taylorsville Road

Ed Murphy, Esq. represented the applicant and provided an overview of the application to consolidate three existing parcels into two parcels with a lot line change. Each parcel will have separate on lot wells and sewage disposal. Following discussion, a motion was made by Ms. Nolan and seconded by

Ms. Traina to approve the lot line change for 945 Taylorsville Road subject to: 1) compliance with the Township Engineer's letter dated September 16, 2021; and 2) a note being included on the plan indicating that there shall be no further building lots on the property. The motion also included a grant of the waivers set forth in Paragraph C.5 of the Township Engineer's review letter. Those waivers included: SALDO §22-324 (street trees), SALDO §22-404 (road widening along fronting roads), SALDO §22-409 (sidewalks constructed along fronting roads), SALDO §22-410 (curbs to be provided along fronting street), and SALDO §602.A to allow preliminary/final approval. Motion carried by unanimous vote.
