Upper Makefield Township Board of Supervisors September 21, 2021 Meeting Minutes

The September 21, 2021 meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. Participating were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan, Treasurer Tim Thomas, Member Ed Ford and Member Karin Traina. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

ANNOUNCEMENTS

Mr. Cino made the following announcements:

- An executive session was held before this evening's meeting for discussion of potential litigation.
- River Road remains closed between Taylorsville Road and Rt. 532 until PennDOT makes the needed repairs. Please do not remove or drive around barricades.
- Residents were reminded that the Tree Grant program is available for reimbursement of up to \$975 toward the cost of purchasing and planting up to 12 Pennsylvania native trees. The rebate form is available on our website or at the Township offices.
- Sept 19-25 is Child Passenger Safety Week. Contact Sgt. Mary Kate Huff to schedule an appointment to make sure your child or grandchild is in the right seat and that it is properly installed.

SOLICITOR'S REPORT

Holly Pond

Ms. Eberle provided an update regarding the Court stipulation agreement for Holly Pond.

Richard Decker, 36 Van Sant Road, asked about the legal process involved, potential outcome for non-compliance, and the ability of the Township to revoke the approved Conditional Use for the property.

A motion was made by Mr. Thomas and seconded by Ms. Nolan to authorize the Township Solicitor to proceed with filing a petition of contempt to have the Court enforce the terms of the stipulation agreement against Holly Pond. Motion carried by unanimous vote.

Waldo and Rosie Alfaro - 675 Eagle Road

Ms. Eberle provided a status report on the non-compliance of Waldo and Rosie Alfaro regarding the use of their 675 Eagle Road property.

A motion was made by Ms. Nolan and seconded by Mr. Thomas to authorize the Township Solicitor to proceed with an enforcement action against Waldo and Rosie Alfaro at 675 Eagle Road to seek a preliminary injunction to stop the current use immediately. Motion carried by unanimous vote.

MANAGER'S REPORT

Presentation of 2022 Preliminary Budget

Mr. Nyman provided a presentation of the 2022 Preliminary Budget developed following the two budget workshop meetings held on September 14, 2021 and September 20, 2021. He thanked the Board and the staff for their efforts during the budget process. The Board also expressed appreciation of staff's efforts.
