Upper Makefield Township Board of Supervisors October 19, 2021 Meeting Minutes

The October 19, 2021 meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. Participating were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Diana Nolan, Treasurer Tim Thomas, Member Ed Ford and Member Karin Traina. Also in attendance were Township Manager David R. Nyman, Assistant Township Manager Judy Caporiccio, Township Solicitor Mary Eberle, Esq., and Chief Mark Schmidt.

CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mr. Cino led in the recitation of the Pledge of Allegiance which was followed by a moment of silence.

ANNOUNCEMENTS

Mr. Cino made the following announcements:

- We are happy to report that River Road is now open in Upper Makefield Township. We again extend our appreciation to PennDOT and the Township team for the coordinated effort to repair and reopen the road ahead of schedule.
- October 23 is the Bucks County Medication Disposal Program. Stop by the Upper Makefield Police station from 10 a.m. 2 p.m. for safe disposal of unused medications. If you can't make it on the 23rd, a drop box is located in the Police Department lobby and is accessible Monday-Friday during business hours.

APPPROVAL OF MINUTES AND BILLS PAYABLE

A motion was made by Mr. Thomas and seconded by Ms. Traina to approve the October 5, 2021 meeting minutes. Motion carried by unanimous vote.

A motion was made by Ms. Nolan and seconded by Dr. Ford to approve the October 19, 2021 Bills Payable List in the amount of \$216,246.43. Motion carried by unanimous vote.

SOLICITOR'S REPORT

Ostaniewicz Solar Panel Installation, 1042 Washington Crossing Road

Ms. Eberle provided an update regarding the Ostaniewicz Solar Panel Installation proposal and advised the Board that the applicant has been in communication, has indicated that an extension would be forthcoming, but has not provided an extension as of the start of the meeting. A motion was made by Ms. Nolan and seconded by Ms. Traina to deny the application, subject to a condition that if an extension is received in the next 48 hours, there will be no denial, and the matter will be extended. Motion carried by a unanimous vote.

MANAGER'S REPORT

2022 Fee Schedule

Mr. Nyman provided an overview of the proposed 2022 Fee Schedule, which was reviewed at the September 20 Budget Workshop. A motion was made by Mr. Thomas and seconded by Dr. Ford to approve the 2022 Fee Schedule. Motion carried by unanimous vote.

Resolution No. 2021-10-19-01 - Adoption of 2022 Budget

Mr. Nyman introduced the resolution and reviewed the 2022 budget process, noting that the Preliminary 2022 Budget has been advertised, made available for public inspection at the Township office, posted on the Township website and may be considered for adoption. Mr. Nyman noted that this budget as presented will reduce taxes by 0.3525 mils. A motion was then made by Ms. Traina and seconded by Ms. Nolan to adopt Resolution No. 2021-10-19-01. Motion carried by unanimous vote.

Resolution No. 2021-10-19-02 - Tax Levy

Mr. Nyman introduced the resolution establishing the 2022 Real Estate Tax rate. A motion was then made by Mr. Thomas and seconded by Ms. Traina to approve Resolution No. 2021-10-19-02. Motion carried by unanimous vote.

Resolution No. 2021-10-19-03 - Adoption of Bucks County 2021 Hazard Mitigation Plan Update Mr. Nyman introduced the resolution adopting the Bucks County 2021 Hazard Mitigation Plan Update. Following discussion, a motion was made by Ms. Nolan and seconded by Dr. Ford to approve Resolution No. 2021-10-19-03. Motion carried by unanimous vote.

Public Works Equipment Sale 2006 Ringo Trailer

Mr. Nyman reported on the bid for sale of a 2006 Ringo Trailer that was listed on Municibid. A motion was made by Mr. Thomas and seconded by Ms. Traina to accept the bid of Jacques Colmaire in the amount of \$800.00 for the purchase of the 2006 Ringo Trailer. Motion carried by unanimous vote.

Crafco EZ Pour Melter with Wire Brush

Mr. Nyman reported on the bid for sale of a Crafco EZ Pour Melter with Wire Brush that was listed on Municibid. A motion was made by Ms. Nolan and seconded by Dr. Ford to accept the bid of Lacy Ponsart in the amount of \$3,000.00 for the purchase of the Crafco EZ Pour Melter with Wire Brush. Motion carried by unanimous vote.
