Upper Makefield Township Board of Supervisors January 3, 2023 Reorganization Meeting Minutes

The January 3, 2023 Reorganization meeting of the Upper Makefield Township Board of Supervisors was called to order by Mr. Cino at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Tom Cino, Ed Ford, Tim Thomas, Yvette Taylor and Ben Weldon. A motion was made by Mr. Weldon and seconded by Dr. Ford to approve the hiring of Luis Colon for the position of full-time Laborer effective January 18, 2023. Motion carried by unanimous vote.

Generator Replacement

Mr. Nyman informed the Board that the 23-year-old emergency generator located at the Township complex is no longer functioning and needs to be replaced. Staff researched COSTARS options and the estimated cost of replacement is \$70,000 - \$80,000, which was not budgeted in 2023.
