LIASION REPORT

Board of Supervisors - Dr. Ford

Dr. Ford provided Board of Supervisor status on the following topics:

- BOS supports the local businesses and would like to see this Pharmacy go forward.
- The BOS also gave approval for Triumph-439 Brownsburg Subdivision and Conditional Use with conditions regarding Wetland transitions easements are no-mow.

WC HERITAGE PHARMACY, 1091 GENERAL KNOX ROAD - SKETCH PLAN

Edward Murphy, Esq., Mark Havers, Engineer and Manoj Parikh, Owner, provided an overview of the applications requesting review and acceptance of the WC Heritage Pharmacy Land Development request as stated in the public notice. Discussion continued with the following topics:

- Edward Jones lease goes until 2031. Edward Jones' parking volume is currently 2 customers a day with 2 employees.
- Parking has 19 spaces, falling short of ordinance requirements. Wells Fargo has 29 parking spaces of which the Pharmacy will have 3 of those spaces. A crosswalk from the bank to the Heritage Pharmacy can be addressed. The employees will park at the Bank. (39 spaces are required for the ordinance so asking for non-conforming status as it has been in the past).
- Stormwater management would need to be implemented. Parking lot will be asphalt.
- Intention is to keep architecture esthetically matching the neighborhood.

Public Comment:

Judy Goldstein of 1215 General Washington Blvd stated she is in favor of the plan.

Greg Dwornikowski of 10 Dunkin Dr. stated the Pharmacy is an asset to the community and is in favor of going forward with this plan.

Since this is a sketch plan, no vote is required.
