Upper Makefield Board of Supervisors October 17, 2023 Meeting Minutes

A motion was made by Mr. Thomas and seconded by Ms. Taylor to approve the October 3, 2023 Budget Workshop meeting minutes. Motion carried by 4-0-1 vote with Dr. Ford abstaining.

A motion was made by Mr. Weldon and seconded by Mr. Thomas to approve the October 3, 2023 meeting minutes. Motion carried by 4-0-1 vote with Dr. Ford abstaining.

A motion was made by Mr. Thomas and seconded by Ms. Taylor to approve the October 17, 2023 Bills Payable List in the amount of \$92,407.95. Motion carried by unanimous vote.

Pension Funds – Revised Annual Minimum Municipal Obligations

Ms. Caporiccio explained that the Actuary Report was received after the Board approved the MMOs in September, and the revised MMOs are updated to reflect that report. Following discussion, a motion was made by Dr. Ford and seconded by Ms. Taylor to approve the revised Police MMO and Non-Police MMO and authorize the Assistant Township Manager to sign the revised MMOs. Motion carried by unanimous vote.

1997 International Dump Truck

Ms. Caporiccio reported on the bid for the sale of the 1997 International Dump Truck with brine tank and snowplow, which was listed for sale on Municibid. A motion was made by Mr. Weldon and seconded by Mr. Thomas to accept the bid for the sale of the 1997 International Dump Truck to Daniel Graybeal for the purchase price of \$10,200. Motion carried by a unanimous vote.

Presentation of 2024 Preliminary Budget

Ms. Caporiccio provided a presentation of the 2024 Preliminary Budget developed following the two budget workshop meetings held on September 13, 2023 and October 3, 2023. She explained that the budget will be available for public inspection on the Township website and at the Municipal Building after Board approval. Following the presentation, the Board expressed appreciation of staff's time and efforts during the budget process and in developing this document. A motion was made by Mr. Weldon and seconded by Dr. Ford to authorize advertisement of the 2024 Preliminary Budget. Motion carried by unanimous vote.
