# Upper Makefield Environmental Advisory Council July 9, 2024 Meeting Minutes

# **CONFIRMATION OF QUORUM**

Chair Cathy Magliocchetti confirmed a quorum.

# PUBLIC COMMENT

Kevin Holmes of 476 Stoneybrook Rd. came with concerns for the neighbors upstream that are not maintaining their section on Jericho Creek and the erosion that has been caused due to the lack of maintenance and the property damage that could result if the neighbors do not respond to his requests for correction.

A motion was made by Mr. Baldwin and seconded by Mr. Barfoot to send request to the Board of Supervisors (BOS) to review and request engineering analysis on the log jam in Jericho Creek with removal of debris that is impeding the creek. Motion carried by a unanimous vote.

# APPROVAL OF MINUTES

A motion was made by Mr. Baldwin and seconded by Mr. Barfoot to approve the June 5, 2024 meeting minutes with amendments as stated. Motion carried by a unanimous vote.

# JERICHO CREEK - PLANNING - PROJECT INTRODUCTION COMMUNICATION WITH SYCAMORE FARMS AND STONEYBROOK ROAD RESIDENTS

Ms. Magliocchetti provided an overview of the project. Discussion followed with the following topics:

- EAC to extend an invitation to a public meeting to present the findings and recommendations for Jericho Creek.to all the residents in the Jericho Creek area between Eagle Road and the Delaware River. This invitation to be sent via a letter. EAC to work on this letter with samples and drafts at a future EAC meeting.
- Discussion of the community meeting content. Agreement that the presentation will include a map of the area to be able to show where recommended projects have been identified. Direction to be as specific as possible with the residents, with explanation of the problems and the recommended solutions.

- Engineering support was discussed to assist with technical understanding for the residents. Suggestions ensued that this may be LandStudies Engineers or the Township Engineer.
- There was general agreement that EAC is targeting October, 2024.
- The EAC will have Riparian Grant applications available at the meeting for the residents who would be interested in moving forward with a project on their property.

A motion was made by Mr. Baldwin and seconded by Mr. Barfoot to recommend that the Board of Supervisors grant an EAC request for the Township Engineer and Land Studies (via Zoom) to attend an EAC community information meeting. Motion carried by a unanimous vote.
