Upper Makefield Environmental Advisory Council November 12, 2024 Meeting Minutes

PLEDGE OF ALLIANCE

CONFIRMATION OF QUORUM

Chair Cathy Magliocchetti confirmed a quorum.

PUBLIC COMMENT

There was no public comment.

APPROVAL OF MINUTES

A motion was made by Mr. Baldwin and seconded by Ms. Radow to approve the October 8, 2024 meeting minutes with amendment. Motion carried by a unanimous vote.

<u>COMMUNITY DAY – REVIEW DISCUSSION FOR TOWNSHIP SURVEY</u>

Mr. Hale and Ms. Dorph attended. Mr. Hale provided an overview of the Event:

- Went extremely well. Impressed by turn-out.
- Recommend advertising to commence earlier. Also, proposed a rain-date.
- Proposed the use of tents for the booths.
- Participants felt the event to be approximately one hour too long.
- Propose to have Food Truck as food went quickly.
- Have 15 minute "tech" talks for the event (to include talks about composting and students to present a talk).
- Will need more Crisco on site next year for the bird feeders.

TREE GIVE AWAY – REVIEW DISCUSSION

Ms. Dorph provided an overview of the Tree Give Away project:

- Very successful.
- People loved the event and the interaction with the EAC, and distribution went smoothly.
- 50% of people signed up, actually picked up.
- Next year will request an email address on the request form for residents wanting trees.
- Would like to request a Township truck to pick up the trees from the donation organization next year.
- Ms. Dorph stated she can get "a ton-of-trees" if the Board of Supervisors would like to request that EAC work on a planting plan.

- Appreciation for Ms. Dorph being available to advise on the different types of trees and how to care for them.
- Suggestion for Township to consider a future tree planting project utilizing Tree Grant Funding. If provided enough lead time, the EAC would like to give out the trees at Community Day.
- Consideration for preparing additional information for the Tree Grants at Community Day.
- Discussed the labeling of the trees that was done by Ms. Dorph.
- EAC recommended planting 20 trees at The Enclave.
- Mt. Eyre Manor properties will be considered in the future for planting.
- Planting along Woodhill Road was a large project that Ms. Dorph was involved in (Timber Knoll HOA). Photos from Township planting are available.
- Requests were made for volunteers for the Live Staking planting project.
- Live Staking was discussed as a possibility for Jericho Creek.

BUCKS BEAUTIFUL PROGRAM – PLANNING DISSCUSSION.

Discussion followed with the following topics:

- Brownsburg Park vs. Lookout Park Much more available area at Brownsburg Park.
- Suggestion to send square footage (3200 sq. ft) to Bucks Beautiful to evaluate the cost-share for the project. Can adjust the plan as necessary.
- The Plan will be distributed via Dropbox to the EAC members.
- Event planned for the Fall (Sept. Oct. 2025).

- Jericho Creek Riparian Repair study to commence with Township Engineers.
