


# **Upper Makefield Response Team**




# **Operations Updates**

- What happened
- Operational steps taken since incident
  - Affected pipe cut out & replaced
  - 20% pressure reduction
  - Visual inspection of pipeline
- No evidence of any additional leaks
- Status of investigation
- Future steps to be taken
  - Inline inspection tool run
  - Additional actions dependent on investigation results




What do we know so far?





### Water Testing

- Area of testing
- Current numbers (as of 2/13/25)
  - 127 tested
  - 92 with results
  - 6 impacted
  - 102 additional tests scheduled
- Increased testing capabilities to meet demand






#### Carbon Filtration Systems

Example of a typical carbon filtration system




