

## 2019 ANNUAL DRINKING WATER QUALITY REPORT

**PWSID #: 1090121      NAME: The Enclave Water System (Township of Upper Makefield)**

This report presents a summary of the quality of public drinking water provided by Upper Makefield Township to the The Enclave Water System during 2019. During 2019, the water provided from the Township's two wells never exceeded the maximum contaminant levels set by the Pennsylvania Department of Environmental Protection (PADEP) and the Environmental Protection Agency (EPA) Safe Drinking Water Act. The Upper Makefield Township Board of Supervisors is committed to providing safe and reliable drinking water service to all of its valued customers and to inform them of the quality and safety of their drinking water.

We want you to be informed about your water supply. If you want to learn more, you may attend any of the Township's Board of Supervisors scheduled meetings. They are typically held on the first and third Tuesday of each month, 7:30 PM at the Upper Makefield Township Municipal Building, 1076 Eagle Road, Newtown, PA 18940. ### **SOURCE(S) OF WATER:**

The Township water source is derived from two (2) wells isolated within Township easements located within The Enclave subdivision. The system operates year-round and will serve 96 residential connections and on average serves 200 people per day.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. ### **MONITORING YOUR WATER:**

We routinely monitor for contaminants in your drinking water according to Federal and State laws. The following tables show the results of our monitoring for the period of January 1 to December 31, 2019. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of the data is from prior years in accordance with the Safe Drinking Water Act. The date of most recent analysis is noted in the sampling results table.

### **DEFINITIONS:**

*Action Level (AL)* – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

*Maximum Contaminant Level (MCL)* – The highest level of a contaminant that is allowed in drinking water.

MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

*Maximum Contaminant Level Goal (MCLG)* – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

*Maximum Residual Disinfectant Level (MRDL)* – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

*Maximum Residual Disinfectant Level Goal (MRDLG)* – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

*Treatment Technique (TT)* – A required process intended to reduce the level of a contaminant in drinking water.

*pCi/L* = picocuries per liter (a measure of radioactivity)

*ppb* = parts per billion, or micrograms per liter (ug/L)

*ppm* = parts per million, or milligrams per liter (mg/L)

**EDUCATIONAL INFORMATION:**

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA and DEP prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. FDA and DEP regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. **VIOLATIONS:**

In April 2019, the results of laboratory testing for distribution system chlorine residual sampling were reported late to the PADEP. The samples were taken and results were within allowable limits, but were not received by the PADEP by the applicable reporting deadline as a result of a clerical issue. This was a violation of the PADEP regulations, and this is public notice of that violation. The system operator has implemented measures to prevent this issue from reoccurring.

**INFORMATION ABOUT LEAD:**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Upper Makefield Township is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
