

## **NOTICE**

The Zoning Hearing Board (ZHB) of Upper Makefield Township, Bucks County, PA, will hold a virtual public hearing on Monday, March 22, 2021 at 7:00 PM via videoconference, to consider the application of Gary and Katharine Ulrich (Applicant). This application relates to Tax Parcel No. 47-012-006, which is located at 1242 River Road, Washington Crossing, PA, in the CM - Conservation Management Zoning District of Upper Makefield Township. The Applicant proposes an addition to the first floor of the dwelling, below and to align with the existing cantilevered second floor. In order to do so, the Applicant requests a variance from Article IX, § 905.D.3 of the Newtown Area Joint Municipal Zoning Ordinance in order to alter or modify the existing structure by adding approximately 200 square feet to the first floor living area.

The Applicant must electronically submit to [dkuhns@uppermakefield.org](mailto:dkuhns@uppermakefield.org) all exhibits it intends to introduce at the hearing by 12:00 noon on Friday, March 19, 2021. The Zoning Hearing Board, along with its Solicitor, the Township Zoning Officer, the Applicant, and all individuals with an interest in this application will be able to participate in this hearing via video conference.
