

Upper Makefield Board of Supervisors

June 20, 2023 Meeting Minutes

The June 20, 2023 public meeting of the Upper Makefield Township Board of Supervisors was called to order by Chair Tom Cino at 7:30 p.m. In attendance were the following members of the Board of Supervisors: Chair Tom Cino, Vice Chair Ed Ford, Treasurer Tim Thomas, Member Yvette Taylor and Member Ben Weldon. Also in attendance were Township Manager David R. Sunoco Pipeline Project Update

Joe Massaro, representative of Energy Transfer, was unable to attend in person but provided the progress report below regarding restoration in the Jacob's Creek Sunoco Pipeline Project area, which Ms. Burmester read aloud. Mr. Massaro will be requested to provide a status update at the next meeting.

Work completed on site:

- Grading work has been completed on site.
- Part of lawn requested to be seeded has been seeded. Mulch has been deployed to stabilize the area.
- Under the guidance of Bucks County Conservation District, some environmental controls have been removed. Removal of silt sock will continue as Bucks County Conservation directs.

Work currently being done on site:

- Irrigation contractor has started work on system. Expected completion by end of next week, weather permitting. Thunderstorms are in the forecast for this week.
- Sod being prepped and installation will begin as weather and irrigation system installation permits.

Remaining work:

- Paving of Oakdale Avenue. A contractor has been secured (HPI) and the schedule is being prepared. The Township will be notified when work will begin.
